By using our website or services, you consent to the collection and use of your personal data as described in this Privacy Policy.

1. Information We Collect

We may collect and process the following personal data:

- **Personal Identification Information**: Name, contact details (email address, phone number), date of birth, and other information you provide directly to us (e.g., through forms, phone calls, or email).
- **Property Information**: Details of properties you are buying, selling, renting, or letting, including property preferences, viewing history, and transaction data.
- **Financial Information**: Bank account details, credit checks, mortgage details, and other financial information necessary for processing transactions.
- **Usage Data**: Information on how you interact with our website, including IP addresses, browser types, device types, and website navigation data.
- **Communication Data**: Any communication you have with us, including via phone, email, or in-person meetings.

2. How We Use Your Information

We use the information we collect for the following purposes:

- To manage and process your property transactions and related financial activities.
- To offer customer support and respond to your inquiries.

• To comply with legal obligations, including anti-money laundering and fraud prevention requirements.

3. Legal Basis for Processing

We process your personal data based on the following legal grounds:

- Performance of a contract: To fulfill our contractual obligations to you, including processing property transactions.
- **Consent**: Where required, we will seek your explicit consent for processing, particularly in relation to marketing communications.
- Legal obligation: To comply with legal requirements, such as anti-money laundering checks.
- **Legitimate interest**: To improve our services and website, or to prevent fraud, in a manner that does not override your rights and interests.

4. How We Share Your Information

We will not sell or rent your personal data to third parties. However, we may share your information with the following categories of third parties:

- **Service Providers**: Trusted third-party service providers who help us run our business (e.g. Contractors, IT services, payment processors, marketing agencies).
- **Financial Institutions**: Banks, mortgage brokers, and financial institutions involved in the property transaction process.
- **Legal and Regulatory Bodies**: To comply with legal requirements, prevent fraud, or protect our legal rights.
- **Professional Advisors**: Solicitors, surveyors, and other professionals assisting in property transactions.

We require that third parties respect the security of your personal data and comply with applicable laws.

5. Data Retention

We retain personal data for as long as necessary to fulfill the purposes for which it was collected, including legal, accounting, and reporting requirements. When personal data is no longer required, we securely delete or anonymise it.

6. Your Data Protection Rights

Under the UK GDPR, you have certain rights regarding your personal data:

- Right of access: You can request a copy of the personal data we hold about you.
- Right to rectification: You can ask us to correct any inaccurate or incomplete data.
- **Right to erasure**: You can request that we delete your personal data under certain circumstances.
- Right to restriction: You can request the restriction of processing in certain situations.
- **Right to data portability**: You can request a copy of your personal data in a structured, commonly used, and machine-readable format.
- **Right to object**: You can object to the processing of your data for direct marketing or based on legitimate interests.
